At 1536 hours on 4/4/2022 I, Deputy K Davis 2164, and Deputy L Sicko, 2159, were dispatched to 455 Forest Ave in reference to a complaint of a FedEx driver damaging the complainant's lawn with his truck.

Upon arrival we met with the complainant, Sara Kelly, who advised at approximately 1440 hours on 4/4/2022 she received an alert from her doorbell/camera system there was movement in the area of her front yard. Kelly advised she accessed her camera system and observed a yellow in color truck backing out of her driveway. Kelly advised as the truck neared the end of her driveway, the truck left the driveway and a portion of the truck's wheel(s) drove across her lawn near the street in front of her home causing a small rut.

Kelly advised she recognized the truck and the driver in question. Kelly identified the driver as Anthony Jezreel Ishi. Kelly went on to advise that Ishi had previously damaged her yard with his truck on 3/16/22 while making a delivery on behalf of FedEx. Kelly advised she filed a report with the Sheriff's Office for the previous incident and that is how the name of the driver was identified (S2205463).

At the request of Kelly a report for the damage that occurred today was taken and a copy of the case number issued to her.

On 04/04/2022, at approximately 1536 hours, I Deputy L. Sicko 2159 and Deputy K. Davis 2164 were dispatched to [REDACTED], in reference to a complaint of a FedEx truck that damaged the front yard.

Upon arrival we met with the complainant, Sara Kelly, who advised that around 1440 hours on 04/04/2022 that she received an alert from her doorbell/camera that there was motion near the front door/yard. Kelly advised that she accessed her camera system and noticed a yellow in color truck backing out of her driveway. Kelly stated that as the truck neared the end of her driveway, the truck veered off the driveway, and a portion of the tires left a rut in her yard.

Kelly also advised that she recognized both the truck and the driver in question. Kelly identified the driver as Anthony Jezreel Ishi. Kelly also stated that Ishi was the culprit in the previous incident which damaged her property with said truck on 03/16/2022 while making a delivery on behalf on FedEx. Kelly advised that she made a report for previous incident with Fayette County Sheriff's Office and that was how the driver was identified. (S2205463).

At Kelli's request a report for the damage done today was taken and the case number was given to her.
